- Products are sold under the agreement that they are not to be sold (wholesale or retail) on any internet auction website at any time
- All goods remain the property of Stix & Stones Baby until payment has been received in full
- Payment can be made via Paypal or Direct Deposit
- All orders will be sent via Registered Post. unframed products \$9.90 and framed products \$15.00-up to 2 per parcel. We have chosen Registered Post as our preferred method of shipping as it includes insurance up to \$100, and is easy to track. It is the retailer's responsibility to ensure that postage is charged on each order and payment of postage is made to Stix & Stones Baby at the time of payment of the order. Overseas postage – please email us for a quote.
- This is a Dropshipping arrangement – products will be sent directly to the customer from Stix & Stones Baby once payment has been received by the retailer.
